

## Request to Apply Course Withdrawal Policy

This request must be submitted electronically by 11:59pm on the deadline posted on the University Registrar's website (www.registrar.vt.edu). Course(s) with a status of CW will appear on Hokie Spa after final grades and will appear on your transcript with a W grade at the end of the semester but will not count in your GPA hours nor in any GPA calculations. Course withdrawal does not remove you from Canvas. Students using financial aid (scholarships, grants or loans) are strongly

advised to contact the Office of University Scholarships and Financial Aid prior to withdrawing from a course to talk through any potential financial aid inanata
